1 Name of instrument

This instrument is the Public Health (COVID-19 Areas of Concern) Notice 2021 (No 45).

2 Commencement

This instrument commences at 12.00pm (AEST) on 23 May 2021.

3 COVID-19 affected areas, COVID-19 places of high concern, and COVID-19 places of concern

- a. Schedule 1, at or during the stated times for the area or place, to be a COVID-19 affected area; and

- c. Schedule 3, at or during the stated times for the area or place, to be a COVID-19 Place of Concern and subject to any conditions or guidance listed in the Schedule

This instrument revokes all previous Public Health (COVID-19 Affected Areas) Notices.
