### 1 Name of instrument

This instrument commences at 6:00pm (AEDT) on 29 March 2021.

- c. Schedule 3, at or during the stated times for the area or place, to be a COVID-19 Place of Concern and subject to any conditions or guidance listed in the Schedule.
