Public Health (COVID-19 Areas of Concern) Notice 2021 (No 46)

made under the

Public Health (COVID-19 Affected Areas) Emergency Direction 2021, paragraph 1

1 Name of instrument

This instrument is the *Public Health (COVID-19 Areas of Concern) Notice 2021 (No 46)*.

2 Commencement

This instrument commences at 5:30pm (AEST) on 24 May 2021.

3 COVID-19 affected areas, COVID-19 places of high concern, and COVID-19 places of concern

I, Dr Kerry Coleman, Chief Health Officer, identify each area or place mentioned in:

- a. Schedule 1, at or during the stated times for the area or place, to be a COVID-19 affected area; and
- b. Schedule 2, at or during the stated times for the area or place, to be an affected area subject to a stay-at-home requirement, and subject to any conditions or guidance listed in the Schedule; and
- c. Schedule 3, at or during the stated times for the area or place, to be a COVID-19 Place of Concern and subject to any conditions or guidance listed in the Schedule

4 Definitions of terms within this Notice

Definitions of words or terms specific to this Notice are set out in Schedule 4.

5 Revocation

This instrument revokes all previous Public Health (COVID-19 Affected Areas) Notices.

Affected persons who are ACT residents must comply with Part 2 of the Direction.

Affected persons who are not ACT residents but who are already within the ACT prior to commencement of this Notice must comply with Part 4 of the Direction. All other non-ACT residents who are affected persons must comply with Part 3 of the Direction.

Persons who are not affected persons but have been in a COVID-19 Place of Concern must comply

Close Contact Exposure Locations

The following conditions apply to all Places outlined in the table below.

Residents of the ACT must:

1. Contact ACT Health on (02) 5124 6209.
2. Quarantine immediately for 14 days since attending the venue.
3. Undergo appropriate testing for COVID-19, regardless of whether symptoms are present, as advised by an **authorised person** within ACT Health.

Non-Residents of the ACT must:

1. Not enter the ACT unless they obtain an exemption before arriving.
2. Where an exemption has been granted, comply with all conditions outlined in the exemption documentation.
3. Unless advised otherwise, quarantine immediately for 14 days since attending the venue, regardless of your test result.

Note: Non-Residents of the ACT who travelled to the ACT prior to the commencement of this Notice, must comply with the requirements for Residents of the ACT
