Public Health (COVID-19 Areas of Concern) Notice 2021 (No 142)

made under the

Public Health (COVID-19 Affected Areas) Emergency Direction 2021, paragraph 1

1 Name of instrument

This instrument is the *Public Health (COVID-19 Areas of Concern) Notice 2021 (No 142)*.

2 Commencement

This instrument commences at 10:30am (AEST) on 3 July 2021.

3 COVID-19 affected areas, COVID-19 places of high concern, and COVID-19 places of concern

I, Dr Paul Dugdale, On-Call Chief Health Officer, identify each area or place mentioned in:


- a. Schedule 1, at or during the stated times for the area or place, to be a COVID-19 affected area; and
- b. Schedule 2, at or during the stated times for the area or place, to be an affected area subject to a stay-at-home requirement, and subject to any conditions or guidance listed in the Schedule; and
- c. Schedule 3, at or during the stated times for the area or place, to be a COVID-19 Place of Concern and subject to any conditions or guidance listed in the Schedule.

4 Definitions of terms within this Notice

Definitions of words or terms specific to this Notice are set out in Schedule 4.

5 Revocation

This instrument revokes all previous Public Health (COVID-19 Areas of Concern) Notices.

SCHEDULE 2

Affected Areas subject to a Stay at Home Requirement

Stay at Home – New South Wales

The following conditions apply to all Areas outlined in the table below.

For all travellers who have spent any time in the New South Wales Local Government Areas (LGAs) listed in the table below since 12:01am (AEST) on 21 June 2021:

1. Individuals are required to *Stay at Home* until 11:59pm (AEST) on 9 July 2021, or until 14 days have passed since last in the area, whichever is earlier.
2. Individuals are permitted to leave their premises for the following:
 - o To undertake essential work or study, if they cannot work or study from home or remotely.
 - o To attend usual childcare arrangements, where parents or guardians need to undertake essential work or study.
 - o To shop for essentials like groceries, medicine, and necessary supplies.
 - o To attend to medical or health care needs including compassionate requirements, and looking after the vulnerable.
 - o To attend a facility to receive a COVID-19 vaccination, where the individual is eligible for a vaccination in the ACT, an appointment has been booked, and the individual is not in isolation or in quarantine.
 - o To exercise outdoors, limited to one hour per day.
 - o For essential animal welfare purposes (e.g. to feed pets or livestock that live elsewhere).
 - o Leaving due to an emergency.
3. All individuals aged over 12 years must wear a mask at all times upon leaving their premises for the above-mentioned reasons. Mask wearing is not required if individuals are undertaking vigorous exercise outdoors.

In addition, the following conditions outlined in the *Public Health (COVID-19 Affected Areas) Emergency Direction 2021*, must be complied with:

Residents of the ACT must:

1. Complete a self-declaration form within 24 hours prior to arriving in the ACT, or within 24 hours from the commencement of a COVID-19 area of concern notice.
2. Monitor for symptoms for 14 days from the date last in the area, and if you experience any symptoms of COVID-19 go to a COVID-19 clinic to be tested.

Non-Residents of the ACT must:

1. Not enter the ACT unless they obtain an exemption before arriving.
2. Where an exemption has been granted, comply with all Stay at Home requirements and/or any conditions outlined in the exemption documentation.

Notes:

- If you have been to a COVID-19 Place of Concern (Close Contact Exposure site or Casual Contact Exposure site) you must also comply with the requirements outlined in Schedule 3.

1. Individuals are required to *Stay at Home* until 11:59pm (AEST) on Saturday 3 July 2021.
2. Individuals are permitted to leave their premises for the following:
 - o To undertake essential work or study, if they cannot work or study from home or remotely.
 - o To attend usual childcare arrangements, where parents or guardians need to undertake essential work or study.
 - o To shop for essentials like groceries, medicine, and necessary supplies.
 - o To attend to medical or health care needs including compassionate requirements, and looking after the vulnerable.
 - o To attend a facility to receive a COVID-19 vaccination, where the individual is eligible for a vaccination in the ACT, an appointment has been booked, and the individual is not in isolation or in quarantine.
 - o To exercise outdoors, limited to one hour per day.
 - o For essential animal welfare purposes (e.g. to feed pets or livestock that live elsewhere).
 - o Leaving due to an emergency.
3. All individuals aged over 12 years must wear a mask at all times upon leaving their premises for the above-mentioned reasons. Mask wearing is not required if individuals are undertaking vigorous exercise outdoors.

In addition, the following conditions outlined in the *Public Health (COVID-19 Affected Areas) Emergency Direction 2021*, must be complied with:

Residents of the ACT must:

1. Complete a self-declaration form within 24 hours prior to arriving in the ACT, or within 24 hours from the commencement of a COVID-19 area of concern notice.
2. Monitor for symptoms for 14 days from the date last in the area, and if you experience any symptoms of COVID-19 go to a COVID-19 clinic to be tested.

Non-Residents of the ACT must:

1. Not enter the ACT unless they obtain an exemption before arriving.
2. Where an exemption has been granted, comply with all Stay at Home requirements and/or any conditions outlined in the exemption documentation.
